The nutrition cluster was officially activated, led by the Family Welfare Division (FWD) of Department of Health Services (DoHS) of Ministry of Health and Population (MoHP) to initiate nutrition preparedness and response actions to address nutrition issues in existing COVID-19 targeting to under five years children, pregnant and lactating women and elderly (60 years plus) population. This is the 22nd meeting after activating the nutrition cluster for COVID-19 preparedness and response. The meeting was chaired by Mr. Kedar Raj Parajuli, Chief of Nutrition Section of FWD/DoHS/MoHP as well as Nutrition Cluster lead of Federal Level Nutrition Cluster and co-chaired by the Mr. Anirudra Sharma, Nutrition Specialist UNICEF as well as Cluster co-lead. Altogether 120 plus people from different Organizations were invited out of which 80 plus attended via zoom link

MAJOR DISCUSSIONS/ACTION POINTS

Agenda 1: Chair of the meeting, scenario setting, welcome and sharing of meeting agenda

Chair of the Meeting: Mr. Kedar Raj Parajuli, Chief of Nutrition Section of FWD/DoHS/MOHP and the National Nutrition Cluster (NNC) Lead Chair the Session with Co-Chairing by Mr. Anirudra Sharma, Nutrition Specialist UNICEF and Co-lead of NNC.

Welcome to the participants and agenda sharing: Chair of the meeting welcome to the all participants and Cochair shared the meeting agenda as mention above.

This was the 22nd virtual nutrition cluster meeting after COVID-19 Global Pandemic disease (COVID 19) arise. In this meeting, altogether 80 plus participants attended (see annex 1 for detail of the participants).

Agenda 2: Progress update from the provincial nutrition cluster lead (PHD directors) focusing on nutrition service continuity and monitoring on ongoing nutrition services.

The Directors from Province 1, Province 2, Bagmati province and Karnali province and representatives from province Gandaki province, Province 5 and Sudur Paschim province presented the progress made by the nutrition clusters in the concerned provinces including the major highlights, achievements, issues and challenges and way forward. The action points:



- Collect and present the information of the under five years children with Severe Acute Malnourished and the information of Pregnant and Lactating suffering from COVID-19.
- Update the stock of nutrition commodities available in different provinces and submit the plan of required RUTF, MNP, Vitamin-A, albendazole and other nutrition commodities as needed. Also, analyse the utilization and beneficiaries of nutrition supplies as well.
- Endorse nutrition in emergency response plan (COVID-19 and monsoon) from MoSD as soon as possible
- Revisit prepositioning of nutrition commodities at provincial and district levels
- Continue health and nutrition cluster meeting as in regular basis
- Continue follow up service monitoring of nutrition programme
- Follow safety precautions for the identification of under five years children with SAM bring these children to OTC and NRH for the treatment wherever relevant.
- Continue health and nutrition cluster meeting at all provinces.
- Coordinate with concerned local governments and District Treasury Control Office (DTCO) to refund the unspent funds allocated for the training in Comprehensive Nutrition Specific Interventions (CNSI) and adolescent nutrition as well as ask local governments to submit the SOEs who have not yet submitted the SOEs and one pager report to FWD/DoHS/MoHP as soon as possible.

The major action points of TWGs are as follows:

- Plan a policy level meeting with team of MoHP for feedback, recommendation and suggestion for FAMILY MUAC approach for implementation.
- Provide Adolescent Nutrition Guideline, 2077 to all the people at provincial and local level for implementation of adolescent nutrition program.
- Request for approval of Standardized Monitoring and Assessment in Relief and Transition (SMART) Methodology 2020 which is already endorsed by the Nutrition Cluster.

Recommendation: As proposed by MN technical working group, the next round Vitamin A campaign will be implemented throughout the country on 11 and 12 Magsir 2077 (26 and 27 November 2020).

Note: The briefing of TWG has been forwarded with this minute.

Other activities:

Mr. Krishna Prasad Lamsal of Family Welfare Division/ World Food Program Shared the overview of national Nutrition guideline which was prepared for COVID-19 positive cases and endorsed by MOHP which was recommended by nutrition cluster from last meeting. He also shared that FWD is working on preparation of Nutritious Menu for lunch based on RDA of ICMR.

Action point: FWD/DoHS/MoHP to share the approved guideline to all nutrition cluster members and provincial nutrition cluster to share this guideline to all concerned authorities and local governments.

Remarks from Mr. Shalik Ram Bhusal MoEST, section Chief/deputy director and Focal person of ECD:

Mr. Bhusal thanked to all the nutrition cluster lead, co-lead and team for making a part of nutrition cluster. He shared that the nutrition team of FWD will be consulted for the preparation of the guideline by MOEST and share with the team of FWD and nutrition cluster members. Mr. Bhusal expects that he will be attending the nutrition cluster meeting as regular basis.



Remarks from Dr. Dipendra Raman Singh, Director General of DoHS/MoHP:

Dr Dipendra apology that he must attend other zoom meetings also therefore unable to attend full time in nutrition cluster meeting. 1. Major Progress made after last nutrition cluster meeting:

- Nutrition cluster developed interim guidance notes on IMAM, IYCF, NIS, SOP for BSFP and disseminated to all relevant health facilities.
- Developed nutrition guideline targeting to different 9 groups of COVID-19 positive cases and now on the process of endorsement from MoHP
- Prepared COVID-19 response plan and monsoon response plan at federal and 7 provinces.
- Ongoing distribution of Supercereal (blanket supplementary feeding programme) in five districts in Karnali, 4
 districts of Province 2 and Solukhumbu districts. So far, 142,138 children aged 6-23 months and 84,839 pregnant
 and lactating women received Super cereal.
- Ongoing transportation of 65 MT Supercereal to Bagamati province, Gandaki province, province five and Sudur Paschim province
- 619 OTCs (out of 718) and 18 NRH (out of 21) are functional and from these centres 4,359 children with SAM
 were treated using Ready to Use therapeutic food. 152 SAM cases were admitted to the outpatient treatment
 programmes in the last week.
- Initiated process to revise BMS act 2049 and revised draft has been prepared and endorsed from Breast Feeding Promotion and Protection Sub-committee and recommended to Breast Feeding Protection and Promotion Committee to the MoHP
- Initiated to develop NRH guideline, consultant identified, outline prepared and proposed in the joint meeting of facilitators group and technical committee
- · Finalizing the revised version of IMAM guideline and five years costed action plan.

2. Challenges

- Resource gaps of supplementary feeding for the prevention of acute malnutrition of 6-59 months children, pregnant and lactating women.
- Nutrition supplements to the children and PLWs in the isolated COVID-19 cases
- The lockdown and curfew imposed in many districts where there are more COVID-19 cases affects the utilization of essential health and nutrition services.
- There are difficulties and constraints to screen, identify and refer children aged 6-59 months who are severely wasted for treatment at Outpatient Therapeutic Centers (OTC).

3. Way forward/next steps:

- Advocacy for leveraging of the resources for supplementary feeding programme
- Organize a policy level meeting among Director FWD, DG of DoHS, Head of Planning and Coordination Divisions of MoHP on Family MUAC approach.
- Endorsement of nutrition guideline for COVID-19 positive cases
- Amendment of BMS act
- Endorsement of Nutrition Assessment Guideline (SMART survey)
- Continuation of ongoing nutrition service
