FRIDAY, 16th Aswin 2077 (2rd October, 2020)

The nutrition cluster was officially activated, led by the Family Welfare Division (FWD) of Department of Health Services (DollS) of Ministry of Health and Population (MoHP) to initiate nutrition preparedness and response actions to address nutrition issues in existing COVID-19 targeting to under five years children, pregnant and lactating women and elderly (60 years plus) population. This is the 23rd meeting after activating the nutrition cluster for COVID-19 preparedness and response. The meeting was chaired by Mr. Kedar Raj Parajuli, Chief of Nutrition Section of FWD/DoHS/MoHP as well as Nutrition Cluster lead of Federal Level Nutrition Cluster and co-chaired by the Mr. Anirudra Sharma, Nutrition Specialist UNICEF as well as Cluster co-lead. Altogether 120 plus people from different organizations were invited out of which 80 plus

- Nutrition cluster partners at federal and provincial levels will create awareness to use the national nutrition guideline developed for covid infected cases and make practiced in all isolation centre and hospitals

- Coordinate with concerned local governments and District Treasury Control Office (DTCO) to refund the unspent funds allocated for the training in Comprehensive Nutrition Specific Interventions (CNSI) and adolescent nutrition as well as ask local governments to submit the SOEs who have not yet submitted the SOEs and one pager report to FWD/DoHS/MoHP as soon as possible
- Revitalize OTCs of Province 1 (Jhapa, Sunsari and Morang), Bagamati Province (all 13 earthquake affected districts and Chitwan) and Gandaki Province (Baglung, Gorkha and Myagdi districts)
- Prepare for National Vitamin A campaign which is already decided for 11 and 12 Magsir 2077 (26 and 27 November 2020)

Remarks from Shalikram Bhusal, Chief/Deputy Director and focal person of ECD from MoEST:

Mr. Bhusal said that ESC section has been working on school midday meal program and updating its guideline with the support from different sectors. He gave a brief update about the guideline and its working mechanism. He thanked to all the cluster members for updating from the field.

Remarks from Dr Bhim Singh Tinkari, Director of FWD:

Dr Tinkari thanked to all provincial team and TWG for excellent presentation. He requested to the provincial Directors to manage a zoom link for annual review of nutrition programme so that participants from the federal level can be participated in the review meeting also. He also requested to all provinces to send a plan with requests for nutrition commodities and based on the request, all nutrition commodities will be provided as soon as possible.

Remarks from Dr. Dipendra Raman Singh, Director General of DoHS/MoHP:

Dr Dipendra Raman Singh, DG of DoHS started his remarks with apology for delay where three zoom meetings were going together, and he was unable to manage his enough time for this meeting. He thanked to Mr. Anirudra Sharma, Co-lead of Nutrition Cluster for an update and support to make this meeting effective. He also thanked to all provincial Directors and provincial team, members of federal level nutrition cluster. He appreciated for the ongoing activities of Nutrition Section of Family Welfare Division (FWD) and thanked to Director of FWD and Chief of Nutrition Section Dr Bhim Singh Tinkari and Mr. Kedar Raj Parajuli and their nutrition team. He also requested to be more pro-active with well planning and implementation to identify and treat malnourished children. He also requested to every one of the federal and provincial nutrition clusters to spread and fill up Home Isolation operation which will be shared to the Chief of Nutrition Section of FWD and will be forwarded to all the participants. At the end he assured that he will be attending in the next meeting and will give full time with feedbacks, suggestions and inputs.

Remarks from Dr. Usha Jha, Honorable Member of National Planning Commission (NPC):

Dr. Usha Jha, Honorable Member of National Planning Commission (NPC) Started her remarks with her apology not being able to join the meeting since the meeting started. She appreciated for the nutrition cluster initiative which is supporting to update of provincial information on nutrition. Every two weeks, nutrition cluster has plan and progress review from all 7 provinces which is very good and effective in this COVID-19 situation. She added that, based on planning, implementation of action points has been ongoing in the field which is good to improve the nutrition situation of maternal, infant and young children in this COVID-19 context. Honourable member Dr Jha thanked to the Chief of Nutrition of FWD, Nutrition Specialist of UNICEF and provincial team for these progressive actions. She further added that Nutrition is a big development as well as humanitarian agenda that supports for personal, economic and national growth and development. Lack of nutrition diminishes all kind of growth. Through nutrition cluster we can empower, capacitate people at different levels and support for programme implementation. She said that we are more focused on physical infrastructure rather than social infrastructure and development and social infrastructure and development should be focused more to support SDG. She requested to all participants to provide a strong support for social development. 

2. Major Progress made after last nutrition cluster meeting:

- Nutrition cluster developed interim guidance notes on IMAM, IYCF, NIS, SOP for BSFP, SMART survey methods and
- Developed nutrition guideline targeting to different 9 groups of COVID-19 positive cases and now on the process of
- Prepared COVID-19 response plan and monsoon response plan at federal and 7 provinces.
- In addition of earlier procured 2000 cartons of RUTF, UNICEF procured 4,000 cartons RUTF and handed over to Central
- Ongoing distribution of Supercereal (blanket supplementary feeding programme) in five districts in Karnali, 4 districts of Province 2 and Solukhumbu districts. So far, 143,514 children aged 6-23 months and 84,839 pregnant and lactating
- Transported 65 MT Supercereal to Bagamati province, Gandaki province, province five and Sudur Paschim province and
- 620 OTCs (out of 718) and 18 NRH (out of 21) are functional and from these centres 4,708 children with SAM were treated using Ready to Use therapeutic food. 340 SAM cases were admitted to the outpatient treatment programmes
- Initiated to develop NRH guideline, consultant identified, first draft prepared and discussed among resource persons, facilitators group and technical groups
- Finalizing the revised version of IMAM guideline and five years costed action plan.
- Planning to evaluate current Breast-feeding status
- Finalized dates for next round national vitamin A campaign

3. Challenges

- Resource gaps of supplementary feeding for the prevention of acute malnutrition of 6-59 months children, pregnant
- Nutrition supplements to the children and PLWs in the isolated COVID-19 cases
- There are difficulties and constraints to screen, identify and refer children aged 6-59 months who are severely wasted for treatment at Outpatient Therapeutic Centers (OTC).

4. Way forward/next steps:

- Further, advocacy for leveraging of the resources for supplementary feeding programme
- Finalize approach paper of Family MUAC and approve from the MoHP
- Initiate approval process of SMART survey methods
- Amendment of BMS act
- Preparation for bi-annual Vitamin A campaign, MNP distribution and MUAC screening to identify the SAM children
- Initiate approval process of Costed five-year action plan for nutrition specific interventions and revised IMAM national
